

### FAO Hunger Map










### Hunger and Agricultural Export Production

## The Food Security Standard (FSS)

Developed to help the **private sector** to respond to food insecurity and human rights due diligence obligations.

Aims to foster **zero hunger at the production level** of global agricultural value chains.

Based on the Human Right to adequate Food.







## Safeguarding Food Security with the FSS


Right to adequate Food is protected by producers of agricultural commodities within their field of responsibility

- Farmers and workers are food secure
- Food security in area of influence does not deteriorate.





# On a well-managed plantation, the road to FSS compliance is short

- FSS Add-On together with ISCC EU and PLUS
- FSS audit scope: Only farm
- Gremca achieved FSS compliance within only two months. Many improvements, including
  - Human rights policy established right to food is included
  - Nutrition training implemented
- FSS support:
  - Training of auditors
  - Workshops to help achieve compliance
  - Accompanying advice during the audit
